		2. This is the disposal of petition for Pre-Arrest Bail
		presented through counsel on behalf of accused Haji
		Marwat Khan, charged in FIR bearing No.47 Dated 09-04-
		2021, registered under Sections 337-A(ii),337-
		F(i),506,148,149 of the Pakistan Penal Code 1860, in
		Police Station Kalaya Lower Orakzai.
		3. Allegations are that accused along with co-accused
		assembled at the spot and restricted the complainants from
!		cultivation of the agricultural property possessed by the
		complainant. He has been beaten by the accused;
		wherefrom, he sustained injuries. It is also alleged that
		accused extended threats of dire consequences and
		criminally intimidated the complainant. The matter was
		reported to Police and resultantly criminal law was brought
		into motion by registration of case articulated above. Four
		out of five accused, on rejection of their petition for pre-
		arrest bail have been remanded to Judicial Lockup and later
:		on released on post arrest bail by learned Judicial
		Magistrate Orakzai. One of the accused is petitioner in
		petition for pre arrest bail, which is under consideration.
		4. In cases of bail before arrest there must be allegation
		of mala fide and ulterior motive which should prima facie
		be substantiated by material on record. The
		accused/petitioner neither could surface on record any mala
		fide nor could place on record any material to substantiate

injured Muhammad Nawaz, Sadam Hussain and Muhammad Bakhtiar which exclude mala fide on the part of complainant. Furthermore the occurrence has not been denied by both the parties; therefore, admittedly the occurrence has taken place, hence in the circumstance of the case the accused/petitioner failed to make out a case for the confirmation of his ad- interim pre-arrest bail.

- 5. In view the above, the pre-arrest bail petition in hand is rejected and the ad-interim pre-arrest bail granted to the accused/petitioner vide Order dated 17/05/2021 is hereby recalled.
- 6. File be consigned after completion and compilation to District Record Room Orakzai, within span allowed for.
