		accused/petitioner alongwith other co-accused are
i		charged u/s 387 PPC for taking away the excavator
		machine alongwith cash of Rs. 200,000/- of the
		complainant and u/s 337-F(i)/342 PPC for wrongful
		confinement and beating of the driver and cleaner of the
		excavator machine besides forming unlawful assembly
		u/s 148/149 PPC. Out of the aforementioned offences, all
		the sections of law are bailable in nature except offence
		u/s 387 PPC. To the extent of offence u/s 387 PPC the
		complainant has effected compromise with the
		accused/petitioner raising no objection on the
		confirmation of their pre-arrest bail. Moreover, the
		accused/petitioner has joined the investigation and his
		committal to police custody would serve no useful
		purpose for the prosecution.
		Hence, in view of what is discussed above, on
		acceptance of the instant petition, the ad-interim pre-
		arrest bail allowed to the accused/petitioner vide order
		dated 01.07.2021 of this court is confirmed on the
		strength of existing bail bonds. Copy of this order be
