was nominated as accused by name. The accusation leveled against the petitioner in a statement was made with considerable delay of twenty days; that too, without disclosing source of information. The identity of accused has not been tested in identification parade prescribed by the law. No forensic or medical evidence is available on file so far, to connect the accused with commission of offence on its face. No confession or recovery has been affected despite the physical custody of accused granted for two long days. All these facts render the case of the accused as that of further inquiry.

6. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees Eighty Thousands (80,000/-); with two sureties; each in the like amount; to the satisfaction of this Court. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
