Later on, the said Succession Certificate was presented for receiving the amount Saudi Riyals 19,755/- lying in the Embassy of Pakistan, Riyadh, Saudi Arabia which is death compensation amount, but they were directed to mention the particular amount along with shares of legal heirs in the Succession Certificate and hence, the present petition was submitted.</p> <p>Evidence in respect of the verification of legal heirs of deceased has already been recorded. 
