ORDER

Petitioner Muhammad Siddique seeks registration of FIR against the respondents Nazir Gul and 11 others for the allegations that on 18.05.2021 at 10:00 hours at Kandalayi Mishti Mela, the petitioner was ploughing his land where respondents no. 1 to 11 duly armed came on the spot, restrained him from ploughing his land and criminally intimidated him.

The petitioner prior to the instant petition had approached this court for registration of FIR which was disposed off with the following directions;

"Hence, in the view of what is discussed above, petition in hand is disposed of with the directions to the

petitioner to approach the SHO concerned for redressal of his grievance. Needless to mention here that the SHO is bound to register the FIR if the contents of complaint constitute a cognizable offence”.

Accordingly, the petitioner approached the SHO concerned but of no use. Hence, the petition in hand.

(2). As per contents of petition, the report of the petitioner constitutes offence, therefore as per law on the point, on report of the matter to police, the SHO concerned is bound to enter the substance of the matter on the roll of prescribed register and proceed with the matter in accordance with law.

(3). Hence, in the view of what is discussed above, petition in hand is accepted. SHO concerned is directed to register the FIR. Needless to mention that in case, the report of the petitioner was found false, he may be proceeded against in accordance with law. Copy of this order be sent to SHO concerned. Consign.
