		4. Brief facts of the case are such that Mr. Saleem Khan
		SHO of Police Station Ghiljo, Orakzai was reportedly
		available on barricade. A land cruiser jeep of red wine
		color bearing registration No. SAH-27 was stopped for

the man on front seat. Criminal Law was brought into motion against the accused and resultantly, FIR bearing No. 27 dated: 29/07/2021 was registered against the accused by attracting Section 9-D of the KP Control of Narcotics Substances Act, 2019; Section-4 of the Prohibition Order and Section 15 of KP Arms Act 2013, in Police Station Ghiljo of District Orakzai. The Vehicle referred above has been taken into possession by local Police; therefore, application for return of Vehicle and 9MM Pistol is presented which is under consideration.

- 5. Perusal of case file reflects that though the chars has allegedly been recovered from the person setting in the back seat of the referred Vehicle; yet, the recorded owner of the Vehicle (present petitioner) has been given the role of mere having 9MM Pistol. There is no secret cavities in the Vehicle and due knowledge of the petitioner regarding chars in possession of person setting on the back seat of the Vehicle is question of fact to be determined in the stage of trial. The petitioner produced documents in respect of the Vehicle (Original returned and photocopies placed on file) which speaks that he is recorded owner of the same as well as last possessor. There is no rival clement as well and retaining the Vehicle in Police Station will serve no purpose except decay. Similarly, the accused produced valid license bearing No.1-1-0015640-Peshawar, issued to petitioner which speaks volumes about the validity of the possession and ownership of Pistol.
- 6. For what has been discussed above, instant Superdari petition stands allowed. The Vehicle as well as Pistol (both referred above) shall be returned to petitioner subject to furnishing surety bonds to the tune of Rs. 20 lacs and 1 lac respectively, with 02 sureties, each in the like amount to the satisfaction of SHO of Police Station Ghiljo. The petitioner will remain bound to produce the Vehicle as well as Pistol whenever required to Police or Court.
