Perusal of record reveals that offences with which accused/petitioners are charged do not fall within the ambit of prohibitory clause of Section 497 Cr.PC. In such like cases grant of

bail is a rule and refusal is exception. No such extra ordinary circumstances are available on record to justify departure from this rule. Nothing incriminating has been recovered from possession of accused or on their pointation. There is delay of about 06 months in registration of the FIR. Injury sheet of the injured/complainant is placed on file as per which he was referred to Peshawar but neither medico-legal report of any medical officer of THQ, Hospital Kalaya nor any medical report of Peshawar hospital is placed on file. Neither name of the truck driver is not mentioned in the FIR nor his statement is recorded u/s 161 Cr.PC. None of the accused/petitioners have been arrested at the spot. Co-accused have already been released on bail, therefore, accused/petitioners are entitled to concession of bail on the basis of rule of consistency. Investigation has already been completed and accused/petitioners are no more required to the local police for further investigation and useful would be served by keeping purpose no accused/petitioners behind the bar.
