SUMMARY JUDGEMENT 25.09.2023

Zareef Ullah, Plaintiff No. 1/special attorney of other plaintiffs along with Mr. Asad Ijaz Advocate present. Mr. Irfan Hussain, Superintendent/legal representative of defendants also present. Written statement and NADRA record submitted. Counsel for plaintiffs requested for summary disposal of the suit on the basis of available record. Representative of defendants stated that he has got

no objection on the summary disposal of the case. Arguments heard and record perused.

Brief facts in the backdrop are that plaintiffs have filed the instant suit for declaration cum-permanent injunction against the defendants Chairman NADRA, Islamabad and two others to the effect that plaintiffs are brothers inter-se and their correct father's name is **Mina Dar Khan** and their correct mother's name is **Guli Ba Bibi**, however, defendants have incorrectly entered father's name of plaintiff No 1 & 2 as Mir Haider Khan and that of plaintiff No. 4 as Mina War Khan instead of Mina Dar Khan and their mother's name as Guli Pa Bibi instead of Guli Ba Bibi which entries are wrong, illegal and ineffective upon the rights of plaintiffs and liable to be rectified. That defendants were asked time and again to rectify the record but in vain hence, the present suit.

With due process of law and procedure, the defendants were summoned, they appeared through representative. Authority letter was submitted. Written statement along with record was also filed.

Plaintiffs have annexed with their plaint the supporting documents in shape of CNICs of their parents, death certificate of father, service record of plaintiff No. 1 as per which father's name of plaintiffs is recorded as Mina Dar Khan and their mother's name as Guli Ba Bibi. Legal representative of defendants stated that the rectification is possible per NADRA SOPs, therefore, there is no need
