Its theme settled by Law is that proper custody shall be the ultimate goal for which the Court has duly bound to issue order as it thinks fit with simple prerequisite of exercise of discretion judiciously. Perusal of the case record would reveal that in the course of investigation, the Flying Coach mentioned above was taken into possession by Police vide Recovery Memo dated 15-09<sup>2</sup>2023. The petitioner produced the original of documents annexed with the petition (original seen and returned); whereas, photo copies of the documents retained on record. At the moment, there is no rival claimant before the Court as well. Further, no useful purpose will be served if the vehicle is retained in the custody of the local police rather it will damage its physical condition. Hence, the same be returned to petitioner by furnishing surety bonds in the sum of Rs.2500,000/- (Twenty Five Lacs); with two sureties; each in the like amount, to the satisfaction of SHO concerned subject to the condition that the petitioner shall produce the same during trial, if required. Petitioner is further directed not to dispose of the Flying Coach till disposal of the case.
