## <u>SUMMARY JUDGEMENT</u>: 31.05.2021

Brief facts of the case in hand are that the plaintiff, Bait

Ullah, has brought the instant suit for declaration cum

perpetual and mandatory injunction against the defendants,
referred hereinabove, seeking declaration therein that his
correct date of birth is 05.07.1999 according to Matric
record/DMC no. KB88323, Roll No. 92068, while it has been
wrongly mentioned as 01.06.1992 in his CNIC by the
defendants, which is wrong, ineffective upon the rights of the
plaintiff and liable to correction. That defendants were
repeatedly asked to correct the date of birth of plaintiff but
they refused, hence, the instant suit.

- 2. Defendants were summoned, who appeared through their representative namely Syed Farhat Abbas, who submitted written statement.
- order IX-A of CPC, it was revealed that the matter involved in the instant case is very petty in nature, which can be decided through summary judgement as per relevant record.

4. Record reveals that plaintiff through instant suit is seeking correction of his date of birth to the effect that his correct date of birth is 05.07.1999 according to Matric record/DMC no. KB88323, Roll No. 92068, while it has been wrongly mentioned as 01.06.1992 in his CNIC by the defendants, which is wrong, ineffective upon the rights of the plaintiff

and liable to correction. Plaintiff in support of his contention produced the copy of his Matric DMC, Kohat Board wherein the date of birth of the plaintiff has been mentioned as 05.07.1999. So, the Matric DMC, Kohat Board, of the plaintiff clearly negates the incorporation of his date of birth as 01.06.1992 in his CNIC. Further, there is no countered document available with the defendants to rebut the documents produced by the plaintiff in support of his stance. Hence, in these circumstances, the said documents are admissible and reliance is placed on it and is sufficient to decide the fate of the case and no further evidence is required to be produced by the parties. So, the available record clearly

will be the transfer of the plaintiff succeeds and is hereby decreed as prayed for. Defendants are directed to correct the date of birth of plaintiff as 05.07.1999 in their record and in the CNIC of the plaintiff.

6. Parties are left to bear their own costs.
