<u>JUDGMENT</u> 26.10.2023

Impugned herein is the judgment/decree dated 25.07.2023 of learned Senior Civil Judge, Orakzai vide which suit of the respondent/plaintiff has been decreed as prayed for.

Through a suit before the learned trial court, the respondent/plaintiff being Incharge Levi Khasadar, Sub Jail Baber Mela, Orakzai Headquarter, in pursuance of verbal directions of the then Deputy Commissioner Orakzai (appellant/defendant no. 1) has provided food to the inmates of the Sub Jail at the rate of Rs. 140/- per head from July to November, 2017, amounting to Rs. 672,840/-, liable to be paid by the appellants/defendants. The appellants/defendants were summoned who appeared before the learned trial court through District Attorney and submitted written statement wherein besides raising various legal and factual grounds, they contended

that neither the respondent/plaintiff was a contractor nor any such record of providing food to the inmates of jail, is available with him. Pleadings of the parties were culminated into the following issues;

- I. Whether the plaintiff has got cause of action?
- II. Whether the plaintiff is estopped to sue?
- III. Whether the plaintiff is entitled to the recovery of an amount of Rs. 672,840/- as expenditure of food, from July 2017 to November 2017, provided by him to the prisoners in Judicial Lock-up, Orakzai at Baber Mela?

IV. Whether the plaintiff is entitled to decree as prayed for?

V. Relief.

Parties were given opportunities to provide evidence. Accordingly, respondent/plaintiff appeared in the witness box as PW-6 while Gul Mand Khan, Serab Hussain, Roman Khan, Sahib Zameer and Rafi Ullah were also examined as PW-1 to PW-5 respectively. On the other hand, appellants/defendants examined Muhammad Fareed, Assistant Accountant, Deputy Commissioner Orakzai as DW-1.

Perusal of case file shows that the contentions of the respondent/plaintiff as per pleadings is, that he was employee of Orakzai Levy force and has retired from service as Sub-Major in

February, 2018 that in 2017 he was posted as Incharge Levy-Khasadar at Sub-Jail, Orakzai at Baber Mela Hangu. The appellants/defendants in their written statement have neither denied the factum of the employment of respondent/plaintiff nor the factum of respondent/plaintiff being employed as Incharge Levy-Khasadar at Sub-Jail Orakzai at Baber Mela Hangu. The contention of the respondent/plaintiff is also supported by Pension-Roll Data Sheet Ex. PW 6/1 available on file. It is also admitted on record that no contract for supply of food to the inmates of jail was allotted to any contractor from July 2017 to November 2017. It is also not disputed between the parties that respondent/plaintiff being Incharge of Sub-jail, Orakzai at Baber Mela Hangu has provided food to the inmates of jail from July 2017 to November 2017. The factum of supply of food by the respondent/plaintiff to the inmates of jail for the above-said period is supported by statements of PW-1 and PW-2 who were posted at Sub-jail, Orakzai Baber Mela Hangu during the aforementioned period, statement of PW-3, the cook at Police-Line Orazkai Baber Mela Hangu, Sahib Zameer, a constable in nmaa Khan, police department who had supplied food to the inmates of jail on behalf of the respondent/plaintiff. The number of the inmates

of jail is proved from the record of Sub-jail, Orakzai available on file as Ex. PW 5/9. All the record/bills are duly countersigned by the then Assistant Political Agent Upper Orakzai. So far, the rate of the food per person is concerned, in this respect the contract

for June 2016 to June 2017 was awarded at the rate of Rs. 140/per person as evident from supply order of the then Political Agent, Orakzai Ex. PW 5/1. Similarly, the contract from December 2017 to June 2018 has also been awarded at the rate of Rs. 140/- per person, as evident from supply order of the then Political Agent, Orakzai Ex. PW 5/1.

Hence, in view of what is discussed above, the suit of respondent/plaintiff is proved through reasonable and cogent evidence. The findings of the learned trial court need no interference; hence, the instant appeal is dismissed with cost. File of this court be consigned to record room. Copy of this judgment be sent to the learned trial court for information.
