were supposed to have instituted the instant suit with in the period of 30 days, as previously they were permitted and directed to file the same within the period of 30 days.

As for as application for condonation of delay is concerned, it is pertinent to mention here that no valid reason or sufficient cause has been disclosed by the plaintiffs for failure to institute the instant suit after the expiry of 30 days. Furthermore, ignorance of law is no excuse and plaintiffs were represented by their counsel, hence in given circumstances, in case of unaware of law or procedure, plaintiffs were supposed to have consulted their counsel and moreover, it was also the duty of their counsel to have informed them regarding the nature and contents of order dated: 17.10.2022.

As for as application for grant of temporary injunction is concerned, as from the above discussion suit in hand is not maintainable being filed after the expiry of period of 30 days, hence the application in hand is hereby disposed of accordingly.

In light of the above discussion, the applications for grant of temporary injunction and condonation of delay. filed by plaintiffs, are hereby dismissed while application for rejection of plaint is hereby allowed and suit in hand is hereby rejected under Order VII Rule 11. No order as to costs. File be consigned to the record room after its necessary completion, compilation and scanning.
