- 4. To reach to the just conclusion of the matter, the comments of Executive District Officer Education (Male) Orakzai have also been called. It is in the comments that the allegation levelled by the petitioner have been inquired by independent inquiry committee which reports in negative against the petitioner.
- Bare reading of the contents of application speaks that 5. the story narrated therein is mere allegations; that too, of the general nature which can be levelled against any person. The mode and manner as well as date and time of the incident allegedly happened are either ambiguous or not specifically mentioned. The law prescribes that who seeks equity must do equity and when mala fide is sensed, discretion cannot be exercised in such eventuality. The alleged videos of the occurrence when opened in computer do not substantiate the contents of the application. The police as well the Education Department termed the contents of the petition as baseless; whereas, petitioner had not annexed convincing evidence to believe the story as narrated. It is settled notion of the Law that Court is not supposed to shut his eyes from other aspects of the case and to pass order for registration of case on a false report of any complainant. Mala fide of the complainant is floating on the record and exercise of power under Section of 22-A of the Code of Criminal Procedure of 1898 would be an exercise in aid of injustice which is strictly forbidden. Similarly, neither record nor learned counsel for petitioner could have pointed out any facts of circumstances that may be inferred for constitution of cognizable offence.
- 6. For what has been discussed above, the petitioner has failed to disclose information regarding cognizable offence; therefore, application stands dismissed. File be consigned to District Record Room, Orakzai after necessary completion and compilation within span allowed for
