SUIT FOR DECLARATION, CUM PERPETUAL AND MANDATORY INJUNCTION

SUMMARY JUDGEMENT: 20.12.2021

Ghamin, has brought the instant suit for declaration cum perpetual and mandatory injunction against the defendants, permatulian Mazir perpetual and mandatory injunction against the defendants, oranged mentioned as Stori Gul in his CNIC by the defendants, which is wrong, ineffective upon the rights of the plaintiff and liable to correct one date of birth of plaintiff but they refused, hence, the instant suit.

- Defendants were summoned, who appeared through their 2. representative namely Syed Farhat Abbas, who submitted written statement.
- During the scheduling conference within the meaning of order IX-A of CPC, it was revealed that the matter involved in the instant case is very petty in nature, which can be decided through summary judgement as per relevant record. To this effect notice was given to the parties that why not the case in hand be decided on the basis of available record without recording lengthy evidence, as the primary aim and objective of Amended Management Rules in CPC is, "to enable the court to-
 - Deal with the cases justly and fairly;

- Encourage parties to alternate dispute resolution b. procedure if it considers appropriate;
 - Save expense and time both of courts and litigants; and
- Enforce compliance with provisions of this Code." d.

Rehmat Ullah Wazir Shahid Khan, brother of the plaintiff appeared as CW-1 Orakzai ar (Babar Mela) and produced the copy of his CNIC which is Ex.CW-1/1 and according to this, correct name of his father is Chinar Khan and further stated that we are two brothers (He and the plaintiff) and 04 sisters. That the correct name of our father is Chinar Khan and that of our mother is Sarwar Jan.

4. Record reveals that plaintiff through instant suit seeking declaration therein that correct name of his father is Chinar Khan, while it has been wrongly mentioned as Stori Gul, in his CNIC by the defendants, which is wrong, ineffective upon the rights of the plaintiff and liable to correction. Plaintiff in support of his contention produced the copy of CNIC of his brother namely Shahid Khan, wherein the father name of the plaintiff has been mentioned as Chinar Khan. The brother of the plaintiff when appeared as CW-01, fully supported and endorsed the claim of the plaintiff. So, the statement of the one Shahid Khan, the brother of the plaintiff and the CNIC of the brother of the plaintiff clearly negates the incorporation of his father's name as Stori Gul in his CNIC. Further, there is no countered document available with the defendants to rebut the documents produced by the plaintiff in support of his stance, which establishes that the name of the father of the plaintiff has wrongly been mentioned in his CNIC that is against the facts and circumstances. The available record is sufficient to decide the fate of the case and no further evidence is required to be produced by the parties.

5. Consequently, upon what has been discussed above and the jurisdiction vested in this court under order IX-A and XV-A of CPC, suit of the plaintiff succeeds and is hereby decreed
