all these facts and circumstances make the case of accused one of further inquiry Furthermore, the punishment provided for such offence also does not attract prohibitory clause of section 497 Cr.P.C, hence, the grant of bail in such cases is a rule while its refusal as exception however no exceptional circumstances exists in instant case. The accused/petitioners are neither previous convicted nor they have confessed their guilt.

For above, accused are entitled to the concession of bail at this stage, hence, application in hand is accepted and accused/petitioners are released on bail subject to furnishing of bail bonds to the tune of Rs: 80,000/- with two local sureties each in the like amount to the satisfaction of the court.
