central pathology Laboratories (Reg No.507-N) suffers from early stage of transitional cell carcinoma of bladder. In light of this Medical Board understands that as this is a serious decease and can be fatal if left untreated. Hence an urgent assessment of the patient by Specialist Doctor of this disease is mandatory along with advanced investigations and an assessment by multidisciplinary team. In light of this the medical board advises that the patient may be referred urgently to specialist center dealing such type of disease (Institute of kidney Disease IKD Hayatabad Medical Complex Peshawar)."

- 6. Correct criteria for grant of bail to an accused in non-bailable case on medical ground is that the sickness or ailment which the accused is suffering is such that it cannot be properly treated within the Jail premises and that some specialized treatment is needed and his continued detention in Jail is likely to effect the capacity or is hazardous to his life (2000 SCMR-107). In instant case, the opinion of medical board constituted for the purpose of examining the accused and his medical documents fulfil the given criteria and thus retaining the accused in prison is seemingly against the very purpose of administration of Justice.
- 7. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to tune of rupees 100,000/- with two sureties; each in the like amount to the satisfaction of this Court. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
