		presented by accused/petitioners Dosti Khan son of Shareef
		Khan and Saif Ullah son of Dosti Khan, all residents of Ali
		Khel, Tappa Sher Khel, Alaf Khel and Tehsil Upper
		District Orakzai.
		3. Complainant reported against the accused/petitioners
		that they entered forcibly upon his property along with a
:		tractor and started ploughing in his property. When the
		complainant reached to his property after receiving
		information, the present petitioners took their Pistols and
		extended life threats to the complainant by aiming their
		Pistol upon him and also abused him. The Local Police has
		not lodged the FIR which led the complainant to move the
		court for registration of case u/s 22-A of the Code of
		Criminal Procedure, 1898. Resultantly, criminal law was
		brought into motion and FIR bearing No.7 dated: 06-07-
		2021 was registered u/s 506-504-447/34 of the Pakistan
		Penal Code, 1860 in Police Station, Daboori. Two out of
		four accused presented instant pre-arrest bail petition which
		is under consideration.
		4. Arguments of counsel for the accused/petitioners and
		learned APP for State assisted by learned private counsel
		for the complainant heard and record perused.
	1	5. On tentative assessment of record, it reveals that
