- 1. Petitioners through attorney Minhar Ali and through counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Ali Mast Shah, who died on 12.09.2021. Arguments heard and record perused.
- 2. Through publication in daily newspaper "Ausaf" dated; 18th November, 2021 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- 3. It is pertinent to mention here that today the counsel for the petitioners submitted an application for addition of the name of the one Mst: Muzlifa Jan D/O deceased Ali Mast Shah, whose name was inadvertently not mentioned in the main petition. Accordingly the application is accepted and Moharrir of the court is directed to add the name of the one Mst: Muzlifa Jan D/O Ali Mast Shah in the column of the petitioners with red ink.
- 4. Petitioner No. 01. Mst: Baswari Jan (widow), 02. Mr. Izzat Khan (Son), 03. Mr. Arif Ali (son), 04. Mst: January (daughter), 05. Mst: Saleema jan (daughter), 06. Mr. Azmeen Ali (son), 07. Minhar Ali (son), 08. Mst: Muzlifa Jan and 09. Khan Sher Ali (son), filed the instant application. Minhar Ali (attorney) recorded his statement as PW-01, Bashir Hassan as PW-02 and Muhammad Safah as PW-03 testified respectively. PW-01 submitted his Copy of his CNIC as Ex.PW-1/1, Power of attorney as Ex.PW-1/2 and Copy of death certificate as Ex. PW-1/3. Further produced the copies of CNICs of the petitioners are exhibited as Ex. PW-1/4 to Ex. PW- 1/10 and Ex. PW-1/13, and further produced Saving Certificates in National Saving Center, Kohat and statement of National Saving Center, Kohat, copies of which exhibited as Ex. PW-1/11

If any legal heirs/objector appears in future, the petitioners and the sureties will be responsible for the payment. Parties are left to bear their own cost. Original succession certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.
