1. Petitioners through attorney Sadiq Khan and through counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Muhammad Anwar, who died on 02.07.2021. Arguments heard and record perused.
2. Through publication in daily newspaper "Ausaf" dated; 31st December, 2021 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
3. Petitioner No. 01. Mr: Sadiq Khan (Son), 02. Mr. Haji Rehman (Son), 03. Mst: Mastana Bibi (daughter), 04. Mst: Soomar Jan (widow), 05. Mr. Raz Muhammad (son), 06. Mst: Silak Jan (daughter), 07. Mst: Safeela Bibi (daughter) and 08. Mst: Saira Bibi (daughter) filed the instant application. Sadiq Khan (attorney) recorded his statement as PW-01, Hikmat Ullah as PW-02 and Fida Muhammad as PW-03 testified respectively. PW-01 submitted his Power of attorney as Ex.PW-1/1, copy of his CNIC as Ex.PW-1/2 and copy of death certificate as Ex-PW1/7. Further produced the copies of CNICs of his mother, his brothers and sisters are exhibited as Ex. PW-1/3 to Ex. PW- 1/6 respectively. Bank statement Ex.PW-1/8. Publication is Ex. PW-1/9. Further PW-02 produced his CNIC which is Ex. PW-2/1 and PW-03, produced his CNIC, Ex. PW-3/1. All the exhibited documents and publication etc are placed on file. Contents of the petition were reproduced and verified by the witnesses.
4. As, there is nothing in rebuttal, therefore, contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit
