		3. Local Police have charged all of the accused for
		illegal use of loudspeaker in the event of death anniversary
		of Allama Arif Hussain al-Hussaini scheduled in Imam
		Bargah of Starr Sam Orakzai. Resultantly, criminal law
		was brought into motion and FIR bearing No.15 dated: 03-
		08-2021 was registered u/s 188 of the Pakistan Penal Code,
		1860 in Police Station, Kurez Boya. All of the accused
		presented instant pre-arrest bail petition which is under
		consideration.
		4. Arguments of counsel for the accused/petitioners and
		learned APP for State heard and record perused.
		5. On tentative assessment of record, it reveals that
		special law dealing the subject of control of loud speaker
		and sound amplifier is available on the subject dealing all

out of the spare of empowering section of law. Similarly, no complainant whatsoever has been received by the Local Police from the Office of the Deputy Commissioner Orakzai and thus procedural irregularity has been committed that speaks about mala fide on part of the Police. The offense is bailable and no evidence even of insufficient degree has ever been tried to be collected except mere assertion in the contents of FIR.

6. For what has been discussed above, instant pre arrest bail petition stands allowed. Ad-interim pre arrest bail earlier granted to the accused/petitioners is hereby confirmed on the strength existing bail bonds. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
