		presented by accused/petitioners Muhamamd Saud s/o
		Deedan Gul and Faiz Ullah son of Raza Khan r/o Sect
		Mishti Tappa Darvi Khel, Shalzara, District Orakzai.
		3. Mr. Saleem Khan SHO and other Police Officials of
		Police Station Ghiljo, Orakzai were on patrolling of the
		area when received spy information regarding smuggling of
		narcotics substance. They had laid barricade near Krappa
		check post. Muhammad Saud s/o Deedan Gul and Faiz
		Ullah son of Raza Khan were moving towards the barricade
:		while riding on Motorcycle. Pursuant to spy information,
		they were searched and 03 packets measuring 1050 grams
		each of chars were found inside the side cover of the
		Motorcycle. Criminal Law was brought into motion against
		the accused and resultantly, FIR bearing No. 36 dated:
		08/10/2021 was registered against the accused/petitioners
		by attracting Section 9-D of the KP Control of Narcotics
		Substances Act, 2019 in Police Station Ghiljo of District
		Orakzai. The accused/petitioners were arrested on spot who
		were later on remanded to Judicial Lockup. Consequently,
		application for release of accused/petitioners on bail is
		presented which is under consideration.
		4. Learned counsel for accused/petitioner and learned
		Assistant Public Prosecutor for State were heard at length
		and file gone through.

carrying chars inside the Motorcycle and were arrested on the spot; but, no private witness has been associated with the recovery proceedings. 03 packets of chars each containing 1050 grams were allegedly recovered from their Motorcycle; yet, report of the Forensic Science Laboratory is still awaited and determination of the recovered narcotics as chars is still awaiting. More so, the prosecution is also not claiming that the accused was previously involved in the same nature of cases. The prime allegation of the Police is that accused was involved in smuggling of chars but the recovery is neither attributed to a particular accused nor shown from direct possession of either of them as the ownership of Motorcycle is yet to be determined. All these facts renders the case of petitioner as one of further inquiry.

- 6. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees 120,000/-; with 02 sureties each in the like amount; to the satisfaction of this Court.
- 7. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
