Order No.07</p>		<p>83, dated 28.06.2021, u/s 302/311 PPC of PS Kalaya, wherein as per contents of FIR, on 28.06.2021, the local police on receipt of information regarding murder of female on the pretext of honour reached on the spot where Mst. Hazrat Meena w/o Sefat Khan was found murdered with firearm. The police also came to know that she was murdered by the present accused/petitioner and his cousin Majid Gul on the pretext of having illicit relations with one, Rehmat Ullah s/o Sunjaf Ali. Hence, the present case.</p> <p>(3). I heard arguments and perused the record. Perusal of case file shows that the accused/petitioner is drectly nominated in the FIR. Counsel for the accused/petitioner failed to point out any malafidi or ulterior motive on behalf of police for falsely implicating the accused/petitioner. Therefore, the instant BBA petition is dismissed and ad-interim bail already granted to the accused/petitioners vide order 21.09.2021 of this Court is recalled.
