That on 10.11.2021 at 07:30 hours, her daughter, while on way to school was stopped by Shah Muhammad Khan, the present accused/petitioner, used abusive language and threatened her, on the pretext of a family suit pending in a Family Court between her daughter and Hidayat Ullah, the son of the accused/petitioner. The matter was inquired by the local police and the instant FIR was registered.</p> <p>Arguments heard and record perused. The accused/petitioner is directly nominated in the FIR. Counsel for the accused/petitioner failed to point out any malafidi or ulterior motive on behalf of the complainant or local police for falsely implicating him in the instant case. Hence, the accused/petitioner is not entitled to concession of pre-arrest bail at this stage. Therefore, ad-interim bail earlier granted to the above-named accused/petitioner is hereby recalled and the BBA in hand resultantly stands dismissed.
