	2	The appellants through a civil suit before the court of Senior Civil Judge, Orakzai have sought declaration with injunctions to the fact that the appellants/plaintiffs are owners in possession of the suit property detailed in the headnote of plaint while the respondents despite having got no concern with the suit property, are bent upon passing a road in the suit property. The plaint was accompanied by application for grant of temporary injunctions. The learned SCJ, Orakzai after admitting the case for hearing issued notice of the application to the respondents/defendants instead of passing restraining order, vide impugned order dated 22.10.2021. The appellants/plaintiffs being aggrieved of the order filed the instant civil appeal. Learned counsel for the appellants/plaintiffs submitted that appellants/plaintiffs have got prima facia case and that the factums of the balance of convenience and irreparable loss also tilt in favour of the appellants/plaintiffs. However, when the learned counsel for appellants/plaintiffs was confronted with the situation that the application for grant of temporary injunctions is pending before the trial court where the prima facia case and the other ingredients for grant of temporary
