## ORDER 29.01.2022

against respondents 3 to 9 for the allegations that the land and adjacent forest situated at village Toll Tangi is the ownership of complainant and villagers of Toll Tangi while the respondents Gul Malook & others have cut trees of forest the complainant, that he approached the DC Orakzai through a written complaint which was marked to local police but no action was taken, hence the present petition.

(2). Comments of the concerned SHO and Forest Officer were called, who accordingly submitted their reports which

are placed on file. I heard arguments and perused the available record.

**(3)**. The law on the point as laid down u/s 154/155 Cr.P.C is. that the **SHO** concerned. on receipt information/complaint regarding the commission of offence, is bound to enter the substance of the complaint on the roll of prescribed register and proceed with the case further. In the instant case, as per comments furnished by the SHO concerned, the petitioner has not made any complaint to the SHO; therefore, let the petitioner first avail the remedy available to him, and if his grievance is not addressed, he may approach this forum.

(4). Hence, in the view of what is discussed above, petition in hand is disposed of with the directions to the petitioner to approach the SHO concerned for redressal of his grievance. Needless to mention here that the SHO is bound to register the FIR if the contents of complaint constitute a cognizable offence. Consign.
