		2. This is the disposal of petition for Pre-Arrest Bail
		presented through counsel on behalf of accused Mesam Ali
		son of Khyal Hassan and Khyal Hassan son of Abdul
		Hassan, all residents of Bar Muhammad Khel, Kurez of
		District Orakzai; charged in FIR bearing No. 02 Dated 03-
		01-2022, registered under Sections 337-A(ii),352, 427/34
		of the Pakistan Penal Code 1860, in Police Station Kurez
		Boya, Orakzai.
		3. Allegations are that accused/petitioners along with
		co-accused visited the house of complainant and beaten
		Hamid Ali on the door step of such dwelling house. Ayeen
		Hassan being brother of the complainant rushed towards
		the spot who was also subjected to stabbing with knife and
		resultantly, both of them sustained injuries. Motive for the
		offence was assigned as dispute over landed property. The
		report of complainant was recorded by local police vide
		Daily Dairy No. 21 dated 03-01-2022. On getting medical
		reports, the above mentioned case was registered. Two out
		of four accused presented petition for pre arrest bail, which
		is under consideration.
		4. In cases of bail before arrest there must be allegation
		of mala fide and ulterior motive which should prima facie
		be substantiated by material on record. The
		accused/petitioner neither could surface on record any mala
		fide nor could place on record any material to substantiate
	-05	any mala fide, harassment or humiliation on the part of complainant. On the other hand the accused/petitioners are charged for causing injuries to the complainant party as

evident from medical reports which apparently excludes the mala fide on part of complainant. In the circumstance of the case the accused/petitioners failed to make out a case for the confirmation of his ad- interim pre-arrest bail.

- 5. In view the above, the pre-arrest bail petition in hand is rejected and the ad-interim pre-arrest bail granted to the accused/petitioner vide Order No.2 dated 15/01/2022 is hereby recalled.
