This is the disposal of Post arrest bail application presented by accused/petitioner Ahmad Hassan son of Shandi Gul r/o Qaum Mishti, Darvi Khel, District Orakzai.</p> <p>3. Mr. Imtiaz Khan SHO of the Police Station Daboori, Orakzai along with other police officials were on routine patrolling of the area. A person moving towards village Malalai from Sampok valley was suspected. He tried to run away but was intercepted properly. On search, 40 grams of Ice has been recovered from side pocket of suspect. Explosive substance numbered as POF1973/36 MM was recovered from other pocket and 9MM pistol with rounds have been recovered from the fold of the trouser of the accused. Criminal Law was brought into motion against the accused and resultantly, FIR bearing No. 08 dated: 11/03/2022 was registered against the accused by attracting Section 11-C of the KP Control of Narcotics Substances Act, 2019; Section 5 of the KP Explosive Substance Act 2013 read with section 15 of KP Arms Act 2013 in Police Station Daboori of District Orakzai. The accused was arrested on spot and later on remanded to Judicial Lockup. Consequently, application for release on bail of the accused is presented which is under consideration.</p> <p>4. Learned counsel for accused/petitioner and learned Public Prosecutor for State were heard at length and file gone through.</p> <p>5. This being stage of bail is required to be cursory and tentative while assessing the record. The accused has been charged for 40 grams of Ice, explosive substance and 9MM</p> |



pistol. The parcel separated for the purpose of examination through channel of Forensic Science Laboratory has already been sent but holding this as Ice is before time. Similarly, the Arms expert of FSL will submit report regarding pistol and explosive material before which, a conclusive opinion cannot be formed. These facts render the case of petitioner as that of further inquiry.

6. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees 150,000/-; with 02 sureties each in the like amount; to the satisfaction of this Court.

7. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
