pistol. The parcel separated for the purpose of examination through channel of Forensic Science Laboratory has already been sent but holding this as Ice is before time. Similarly, the Arms expert of FSL will submit report regarding pistol and explosive material before which, a conclusive opinion cannot be formed. These facts render the case of petitioner as that of further inquiry.

- 6. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees 150,000/-; with 02 sureties each in the like amount; to the satisfaction of this Court.
