10.02.2022. Accused later on appeared on the same day on the closing hours and presented fresh petition for adinterim bail, which is under consideration.

- 4. The record has been consulted for determination of question of granting or withholding the concession of bail in format of bail before arrest.
- 5. On tentative assessment of record, it reveals that motive in honor killing is existing. The petitioner has specifically been named in the contents of FIR. Incriminating material has been recovered from the spot. Above all, neither mala fide nor intention to disgrace and dishonor on part of the complainant or prosecution is being surfaced.
- 6. For what has been discussed above, instant pre arrest bail petition stands dismissed. Ad-interim pre arrest bail earlier granted to the accused/petitioner is hereby recalled. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
