




Record received.</p> <p>The accused/petitioner, Syed Arbab s/o Syed Samin Hussain, r/o Section Kalaya Saidan, Village Kalaya, Tehsil Lower, District Orakzai seeks confirmation of his ad-interim pre-arrest bail in case FIR no. 39, dated 20.04.2022, u/s 3/4 Ghag Act of PS Kalaya wherein, as per contents of FIR, the complainant has charged the accused/petitioner for raising Ghag, restraining the daughter of complainant of marrying.</p> <p>At the very outset, complainant submitted a compromise deed reached between the parties out of the court. The complainant submitted that he has got no objection either upon the release of accused/petitioner on bail or upon his acquittal at the trial stage. To that effect statement of the complainant recorded and placed on file. Arguments heard and record gone through.</p> <p>Perusal of case file shows that though the offence for which the accused/petitioner is charged, is non-compoundable but as the parties are close relatives; therefore, in the best interest of justice, the compromise is accepted and the ad-interim pre-arrest bail allowed to the accused/petitioner vide order dated 27.04.2022 of this court is confirmed on the strength of existing bail bonds.
