

This is the disposal of Pre arrest bail application presented by accused/petitioner namely Muhammad Daud son of Mohabat Khan, resident of Qaum Feroz Khel, Tehsil Lower of District Orakzai.</p> <p>3. Accused/petitioner, named above, seek confirmation of pre-arrest bail, after having been charged in case FIR No. 32 dated 31.03.2022, U/s 324/34/427 PPC, registered at Police Station Kalaya.</p> <p>4. The complainant and injured persons appeared before the Court on previous date of hearing and stated at the bar that they have patched up the matter with the accused/petitioner and have got no objection if BBA petition is confirmed. To this extent, their joint statement was recorded in the Court. Compromise Deed and Copy of their CNIC(s) have been exhibited as Ex.PA, Ex. PB &amp; Ex. PC and were placed on file. Since the parties themselves have forgiven and forgotten the offence; therefore, keeping in view the above, the instant BBA petition is accepted and resultantly, ad-interim pre-arrest bail, already granted to the accused/ petitioners is confirmed on the existing bail bonds. Local police be informed accordingly.
