have been given role of indiscriminate firing over the property and person of complainant. The injury sheet prepared by the Local Police is supported by the Medical documents. It was day light occurrence witnessed by ocular account of evidence. Record further reveals that motive in shape of dispute over landed property is existing. The one of the petitioner has been charged as principal accused with specific role of opening fire that resulted the injuries sustained by injured Safi Ullah. All these facts lead the Court to hold that accused is prima facie connected with commission of offence that falls within the prohibitory clause of Section-497 of the Code of Criminal Procedure, 1898. It is further observed that the trend of recourse to might is right instead of opting legal remedy in civil dispute is the prevailing practice in the Tribal District of Orakzai that need to be focused as a matter of local criminal policy.

- 6. For what has been discussed above, this Court is not inclined to extend the concession of bail at this stage to the principal accused Syed Salam. As far as second petitioner Yousaf Mahmood concerned, he is juvenile with date of birth as 06.02.2009 being reflected in his School Leaving Certificate available on file. Similarly, the role attributed to him is not of firing rather of holding stick which is obviously lesser. Consequently, he be released on bail subject to furnishing 80,000/- with two local sureties, each in the like amount, to the satisfaction of this Court.
- 7. File of this Court be consigned to District Record Room, Orakzai after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
