Arguments heard on application of prosecution for discharge of accused.</p> <p>Accused Abu Bakar s/o Akbar Khan is charged for the offence u/s 9 (d) of Khyber Pakhtunkhwa Control of Narcotics Substance Act, 2019 vide FIR no. 08, dated 31.01.2022 of PS Kalaya wherein, as per contents of FIR, the complainant acting of information regarding smuggling of narcotics by accused Abu Bakar via motorcycle, laid a picket on the spot, where a person riding a motorcycle having registration no. S5635/Bannu of red colour on way from Feroz Khel, on seeing the police party, abandoned the motorcycle alongwith a yellow colour bag and made his escape good from the spot.
