		2. This is the disposal of Post arrest bail application
		presented by accused/petitioners namely Muhammad Sher
		son of Gul Anwar and Izzat Khan son of Yar Akbar, both
		r/o Qaum Ali Khel, District Orakzai.
		3. Mr. Imtiaz Khan I.O, Police Station Daboori,
		Orakzai has forwarded Murasila through Constable Abdur
		Razaq stating therein, that Fazal Rehman son of Arbab
		Khan(complainant/injured) reported the incident that on
		06.05.2022, he along with his brother Muhammad Imran
		while on their way to Daboori Bazar by Motorcycle bearing
		No. F-8472 when reached to the spot of occurrence, the
		accused/petitioners along with other co-accused attacked
·		them with stones and sticks. One of the accused namely
		Muhammad Hussain opened fire through firearm as a result
		of which, he (complainant) sustained injury to his right leg
		while Muhammad Imran luckily escaped. Criminal Law
		was brought into motion and thus FIR bearing No. 13 dated
	NADOOD Se sions Jugge It Hangu	06.05.2022 was registered under sections 324/148/149 of
		the Pakistan Panel Code, 1860 in Police Station Daboori.
		Accused have been remanded to Judicial Lockup which
		necessitated presentation of instant post arrest bail which is
		under consideration.
		4. Learned counsel for accused/petitioners sent written
		arguments while learned Senior Public Prosecutor for State
		was heard at length and file gone through.
		5. This is tentative assessment of record available on
	AZZ R	file as deep appreciation of evidence is neither required nor
	E S	warranted at this stage. Though incident has promptly been

reported by the injured complainant and nominated the accused by specifically naming them as accused; but, the present accused have been charged for attack on the complainant with sticks; wherefrom, no injury whatsoever has been caused from such attack. The question of sharing common object of the petitioner with the principle accused Muhammad Hussain charge for firing is factual in nature that cannot be determined at this stage. This fact alone is sufficient to drag the matter into ambit of further inquiry. Similarly, the co-accused with similar role have already been granted bail by the Hon'ble District & Sessions Judge, Orakzai vide Order dated 17.05.2022 and thus, rule of consistency is very much attracted to the case of petitioners.

6. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees One Lac (100,000/-); with two sureties; each in the like amount; to the satisfaction of this Court. File of this Court be consigned to District Record Room, Orakzai after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
