Hence, the present FIR.</p> <p>On the same day Asif Khan (one of the accused) in the instant case, vide DD no. 11 of 19.05.2022, has made a report to the police to the fact that on that day at 1830 hours, Faiz Muhammad (complainant of the instant case) was ploughing a disputed property through a tractor in the presence of Zahir Muhammad and Sial Muhammad and when he wanted to stop the Faiz Muhammad from ploughing a land, Zahir Muhammad scuffled him while Noorab Khan made firing at him.
