being injured have levelled charges of being beaten with the help of sticks and axe by Abdul Samad, Muhammad Ullah, Safi Ullah, Majid Gul, Sajid Ullah, Samad Ullah, Hakeem Gul, Muhammad Tariq, Mst Niaz Bibi and Mst Amina. Muhammad ullah has been alleged for opening of fire through pistol. The DPP has recorded opinion on such madd to maintain a separate file u/s 452, 437 a(i) f(i), 148, 149 subject to medico legal report.

- 5. The parties have compromised the offence to the extent of female accused of both the sides and their bail before arrest has, therefore, allowed on previous date of hearing.
- 6. Three accused named above have presented instant pre-arrest bail petition, which is under consideration.
- 7. Arguments of counsel for the accused/petitioners, counsel for complainant and APP for State heard and record perused.
- 8. On tentative assessment of record, it reveals that motive of dispute over landed property is existing. All of the petitioners have specifically been named in the contents of FIR. Incriminating materials have been recovered from the spot. Above all, neither mala fide nor intention to disgrace, humiliation, harassment and dishonor on part of the complainant or prosecution is being surfaced.
- 9. For what has been discussed above, instant pre arrest bail petition stands dismissed. Ad-interim pre arrest bail earlier granted to the accused/petitioners is hereby recalled. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
