Complainant and injured present and stated before the court that they have affected compromise with the accused/petitioners and have pardoned them in the name of Almighty Allah. They also stated that they are no more interested in the case against the accused and have got no objection if the accused/petitioners are released on bail, therefore keeping in view the compromise statements of complainant and injured recorded and they thumb impressed the same.

The petitioners namely Mawali Khan and Umar have applied for their post arrest bail in connection with case FIR No. 32, Dated: 31.03.2022, U/S 324/34/427 PPC registered in PS Kalaya, L/Orakzai.

Arguments heard and file perused.

Though, accused are directly charged in the FIR but the main offence, for which the accused are charged are compoundable and the complainant/all the injured have entered into a compromise with the accused party. In addition to, accused are first offenders and have got no criminal history at their credit.

For the above reason, the accused are entitled to the concession of bail at this stage, hence, application in hand is accepted subject to furnishing of bail bonds to the tune of Rs. 100,000/- with two local and reliable sureties each in the like amount to the satisfaction of this court.
