well of the petitioner. Both the parties have been bound, down in security proceeding under Section 107/151 Code of Criminal Procedure, 1898 and matter was referred to District Public prosecutor the opinion. It was opined by the prosecution that it is wrongful confinement and thus FIR bearing No. 14 dated 19-04-2022 was registered under Section 342 PPC in police station Mishti Mela; where, petitioner is complainant and Jannat Noor is accused.

- 4. Learned counsel for petitioner and APP for State have been heard at length.
- Perusal of case file reflects that criminal law has 5. already been brought into motion in favor of petitioner against the respondent vide FIR bearing No. 14 dated 26-03-2022 registered in Police Station Misti Mela by attracting Section 342 PPC that covers the agitated matter of illegal confinement. While taking into consideration the facts and circumstances of the case; that too, without touching merits of the case being under investigation, the grievance of petitioner has already been addressed and no further action is required on part of Ex-officio Justice of Peace.
- 6. For what has been discussed above, petition stands dismissed. Record be returned back with copy of this Order to the quarter concerned. File be consigned to District Record Room, Orakzai after necessary completion and compilation within span allowed for.
