

		was brought into motion against the accused and
		resultantly, FIR bearing No. 53 dated: 22/05/2022 was
		registered against the accused by attracting Section 5 of the
:		Explosive Substances Act, 1908 in Police Station Kalaya of
,		District Orakzai. The accused was arrested on spot who
		was later on remanded to Judicial Lockup. Consequently,
-		application for release of accused on bail is presented
		which is under consideration.

		and file gone through.
