

Order No	16/07/2022	<p>Mr. Sana Ullah Advocate for accused/petitioner and DPP for State are in attendance.</p> <p>2. Arguments heard; whereas, this is the disposal of Post arrest bail application presented by accused/petitioner Shah Nawaz s/o Zahir Gul r/o Qaum Feroz Khel, Mirbak Kalay, District Orakzai.</p> <p>3. Mr. Shal Muhammad, SHO along with other police officials of Police Station Kalaya, Orakzai were on routine patrolling of the area. One Shah Nawaz was moving towards the barricade adjacent to Headquarter Chowk while having 01 plastic bag in his right hand. On suspicion, he was searched and two Hand Grenade were found in same plastic bag, possessed by such person. Criminal Law was brought into motion against the accused and resultantly, FIR bearing No. 53 dated: 22/05/2022 was registered against the accused by attracting Section 5 of the Explosive Substances Act, 1908 in Police Station Kalaya of District Orakzai. The accused was arrested on spot who was later on remanded to Judicial Lockup. Consequently, application for release of accused on bail is presented which is under consideration.</p> <p>4. Learned counsel for accused/petitioner and learned District Public Prosecutor for State were heard at length and file gone through.</p> <p>5. This is tentative assessment of record available on file and deep appreciation is neither required nor warranted. The accused/petitioner was allegedly carrying Hand Grenade in his personal possession and was arrested on the spot; but, no private witness has been associated with the recovery proceedings. The allegedly recovered Hand Grenades have been transported to expert on 08/06/2022</p>



with the delay of 16 days which fact is sufficient to render the case of petitioner as one of further inquiry. Moreover the prosecution is also not claiming that the accused was previously involved in the same nature of cases.

6. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees 120,000/-; with two sureties, each in the like amount; to the satisfaction of this Court.

7. File of this Court be consigned to District Record Room, Orakzai after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
