2. Through publication in daily newspaper "Ausaf" dated; 30th January, 2022 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
3. Petitioner No. 01. Mst: Bibi Gulla (widow), 02. Mr. Atlas Khan (Son), 03. Mr. Muhammad Khan (Son), 04. Mst: Sefat Bibi (daughter), 05. Mst: Safia Bibi (daughter) and 06. Mst: Mafila Jan(daughter), filed the instant application. Atlas Khan recorded his statement as PW-01 and Said Janan as PW-02 testified respectively. PW-01 submitted his CNIC as Ex.PW-1/1, Copies of CNICs of rest of the petitioners are Ex.PW-1/7 to Ex. PW-10, copy of death certificate as Ex-PW1/2. Further produced the copies of CNIC of widow and deceased Meer Jalal Khan which are Ex. PW-1/3 & Ex. PW-1/4 respectively. Further produced pension papers which are Ex. PW-1/5 & Ex. PW-1/6 respectively. All the exhibited documents and publication etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.
4. As, there is nothing in rebuttal, therefore, contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit the legacy of deceased as per following shares;



Original succession certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.
