Shah Zaman (attorney) recorded his statement as PW-1, Muhammad Fayaz as PW-2 and Muhammad Saeed as PW-3 testified respectively. PW-1 submitted his power of attorney as Ex.PW-1/1, Photocopy of my CNIC as Ex.PW-1/2, Death Registration Certificate as Ex.PW-1/3, FRC as Ex.PW-1/4, Copy of CNIC of petitioner No. 1 as Ex.PW-1/5, Copy of Form 'B' of minors as Ex.PW-1/6, The Bank Account statement of HBL Islamic Banking, Bus Ada Branch, District Hangu as Ex.PW-1/7. All the exhibited documents, publication and report of process server etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.

Original succession certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.
