- Petitioners through attorney Mudassir Ali and through counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Dilawar Khan, who died on 10.03.2020. Arguments heard and record perused.
- 2. Through publication in daily newspaper "Ausaf" dated; 17th February, 2022 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.
- Petitioner No. 01. Mr. Mudassir Ali (son), 02. Mr. Musharaf Ali (son), 03. Mst: Shahida (daughter) and 04. Mst: Basmina Jan (widow), filed the instant application. Mudassir Ali (attorney) recorded his statement as PW-01 and Waseem Ali is appeared as PW-02. PW-01 (attorney) submitted his Power of attorney as Ex.PW-1/1, copies of CNICs of petitioners are Ex.PW 1/2 to Ex. PW-1/5 and FRC Ex. PW-1/6. Further produced the copy of death certificate Ex. PW-1/7 and publication is Ex. PW-1/8. Further the Bank Statement is Ex. PW-1/9. PW-02, submitted his CNIC which is exhibited as Ex. PW-2/1. All the exhibited documents and publication etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.
- As, there is nothing in rebuttal, therefore, contention of the 4. petitioners is believed to be correct. Therefore, the petitioners will inherit the legacy of deceased as per following shares;

As, there is no other legal heir of deceased and considering the request of the petitioners being genuine this application is allowed along with accrued profit and Succession Certificate is issued in favour of petitioners, subject to surety bond/undertaking to the tune of Rs. 100,000/- with 02 local sureties each in the like amount to the satisfaction of this court. If any legal heirs/objectors appear in future, the petitioners and the sureties will be responsible for the payment. Parties are left to bear their own cost. Original succession certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.
