1. Petitioners through attorney Syed Wali Shah and through counsel present. The petitioners seek succession certificate in respect of legacy of deceased namely Ali Wahab, who died on 02.12.2020. Arguments heard and record perused.

2. Through publication in daily newspaper "Ausaf" dated; 10<sup>th</sup> March, 2022 general public was asked to submit objections, if any, however, no one appeared before the court, so ex-parte proceedings were conducted.

3. Petitioner No. 01. Mst: Bibi Shah Zahra (widow), 02. Mst: Bibi Kubra Jan (widow), 03. Mst: Roshan Zahra (daughter), 04. Mr. Muazzam Ali Shah (son), 05. Mst: Jehan Zahra (daughter) and 06. Mst: Makazima (daughter), filed the instant application. Syed Wali Shah (attorney) recorded his statement as PW-01, Syed Rehad Hussain as PW-02 and Syed Muhammad Razi Shah is appeared as PW-03. PW-01 (attorney) submitted his Power of attorney as Ex.PW-1/1, copy of death certificate of the deceased Ali Wahab is Ex. PW-1/2, Copy of Form-B of minors is exhibited as Ex. PW-1/3. Further produced bank statement which is exhibited as Ex. PW-1/4 and also produced his CNIC which is exhibited as Ex. PW-1/5. Further PW-02, produced his CNIC which is exhibited as Ex. PW-2/1. PW-03, produced his CNIC which is exhibited as Ex. PW-3/1. All the exhibited documents and publication etc. are placed on file. Contents of the petition were reproduced and verified by the witnesses.

4. As, there is nothing in rebuttal, therefore, contention of the petitioners is believed to be correct. Therefore, the petitioners will inherit the legacy of deceased as per following shares;



As, there is no other legal heir of deceased and considering the request of the petitioners being genuine this application is allowed along with accrued profit and Succession Certificate is issued in favour of petitioners, subject to surety bond/undertaking to the tune of Rs. 100,000/- with 02 local sureties each in the like amount to the satisfaction of this court. If any legal heir/objector appear in future, the petitioners and the sureties will be responsible for the payment. Parties are left to bear their own cost. Original succession certificate be given to the petitioners' subject to surety bonds while copy of the certificate be placed on file.
