JUDGEMENT 11.05.2022

Impugned herein is the order dated 17.03.2022 of Ahman which petition of the petitioner/plaintiff for making contempt of the sessions making contempt of the sessions making court proceedings and the sessions are court proceedings and the sessions are court proceedings learned Civil Judge-I, Orakzai passed in civil suit no. 26/6 vide dismissed.

> (2).Through a suit before learned Civil Judge-I, Orakzai, the petitioner/plaintiff sought declaration-cum-perpetual injunctions to the fact that petitioner/plaintiff is owner in possession of a land measuring 12 Marlas named as Sandali situated at Farid Khan Ghari, detailed in the headnote of the plaint vide a partition deed dated 16.12.2020 while the respondent/defendant, being in possession of his due share, has

got no right to make construction upon the property of the appellant/plaintiff.

The plaint was accompanied by application for grant of temporary injunctions, in pursuance of which the learned trial court on 05.08.2021 allowed the status-quo to be maintained for 14 days, which was extended for further 14 days on 15.09.2021.

During pendency of the suit the petitioner/plaintiff

submitted application for contempt of court proceedings against the respondents/defendants and execution of the court order through SHO. The respondents/defendants submitted reply of the same and the learned trial court after hearing arguments on the maintainability of the petition dismissed the same vide impugned order dated 17.03.2022. Hence, the present revision/petition. Today, the instant revision/petition was fixed for preliminary arguments. Learned counsel for petitioner argued the same at some length; however, during the course of argument whe submitted that as a status-quo for a period of 06 months till disposal of the suit has been allowed by this court to be maintained on both the parties therefore, he does not press the instant revision /petition; however, he may be allowed to submit fresh application for contempt of court before the learned trail court in case of violation of the order of status-quo by the respondents/defendants.

(3). In view of above, the instant revision/petition is dismissed being not pressed with the permission to the petitioner
