



Order	29/03/2022	<p>Mr. Khurshid Alam Advocate represented accused/petitioners, complainant in person and Mr. Javid Akhtar Wazir Sr.PP for State are in attendance.</p> <p>2. This is the disposal of Post arrest bail application presented by accused/petitioners Zahir Shah s/o Musafir Gul and Aziz son of Khayal Ajab Khan residents of Rabia Khel Lakhti Banda District Hangu.</p> <p>3. The complainant reported incident of theft of coils from two transformers installed in the village Satara Samana Orakzai to the local police against some unknown accused. Resultantly, FIR bearing No. 06 dated 21-03-2022 was registered under Sections 380 of the Pakistan Panel Code 1860 in Police Station Ghiljo. Complainant charged present petitioners as accused in his statement recorded under Section 164 of the Code of Criminal Procedure, 1898. Accused were arrested and handed over to Police for two days physical remand. They have later on been remanded to Judicial Lockup. Petition for grant of bail was rejected by learned Senior Civil Judge vide Order No. 3 dated 26-03-2022, which led them to institute petition in hand for release of accused on bail which is under consideration.</p> <p>4. Learned counsel for accused/petitioners and learned Senior Public Prosecutor for State were heard at length and file gone through.</p> <p>5. This is tentative assessment of record available on file and deep appreciation is not required at this stage. Though the incident has promptly been reported but no one was nominated as accused by name as it was initially against unknown person. The accusation leveled against the petitioners in a statement was without disclosing source of</p>

information. No confession has been recorded despite the physical custody of accused granted for two long days. The coils have reportedly been stolen and the accused have been booked only for availability of Motorcycle bearing chassis No. ZXPBA00443; owned and possessed by the accused. Recovery is indirect and even if it is deemed or considered direct possession, the report of petitioners recorded in daily diary for theft of such Motorcycle alone is sufficient to make it case of further inquiry.

6. For what has been discussed above, instant bail petition stands allowed subject to furnishing bail bonds to the tune of Rupees Eighty Thousands (80,000/-); with two sureties; each in the like amount; to the satisfaction of this Court. File of this Court be consigned to District Record Room after its necessary completion and compilation within the span allowed for; whereas, copy of this Order be placed on record of Police to be returned accordingly.
