Arguments heard and record perused.

1. Petitioners 1. Makail (son) 2. Israfeel (son), 3. Hafiz Ullah (son),

4. Abdul Asghar (son), 5. Ranjida Bibi (daughter), 6. Wahida Bibi (daughter) and 7. Lachi Wala (widow) all residents of Qaum AKhel, Tappa Dalak Nawasi, Tehsil Ismailzai, District Orakzai have filed the instant petition against respondents, public at large, for issuance of Succession Certificate being LRs of deceased Din Asghar S/O Khanzada who died on 09.11.2023. Copy of his death certificate attached. 1. That the amount of Rs. 2,152,446.00/- left as the legacy of deceased lying in account No. 1808-79003655-03 in HBL, Ghiljo. 2. That the amount of Rs. 2,562,698.98/- left as the legacy of deceased lying in account No. 1808-00010049-01 in HBL, Ghiljo. 3. That the amount of Rs. 500,000.00/- left as the legacy of deceased lying in account No. 1808-79000055-80.00 in HBL, Ghiljo. According to the petitioners, they are LRs of the deceased named above and there is no other legal heir except

- 2. The respondents i.e., public at large was served through notice in daily newspaper "Ausaf" dated 23.01.2023, but no one appeared before the court, so ex-parte proceedings were initiated. During the course of ex-parte evidence, one Makail being special attorney of the petitioners appeared as PW-01. He produced the following documents.
 - 1. Ex. PW-1/1: Special power of attorney.
 - 2. Ex. PW-1/2 to Ex. PW-1/4: Nadra documents.
 - 3. Ex. PW-1/5 to Ex. PW-1/7: Copies of bank statements.
- 3. PW-02 & PW-03 are the statements of Iltaf and Naimat Ullah respectively. They supported the stance of the petitioner and confirmed that there are no LRs of the deceased except the present petitioners.
 - 1. Ex. PW-2/1 and Ex. PW-3/1: CNICs of PW-02 and PW-03.
- 4. All the exhibited documents, publication and report of process server etc are placed on file. Contents of the petition were reproduced and verified by the witnesses. The report of Muhammad Hussain, Process Server on notice for verification of LRs of deceased is self-explanatory and is confirming the fact that there is no other LRs of the deceased except the them.
