

Accused/petitioner, Habib Raza on ad-interim pre-arrest bail in person with his counsel present. Complainant/Injured Ahmad Raza present in person. Arguments heard.</p> <p>The above-named accused/petitioner seeks confirmation of his ad-interim pre-arrest bail in case FIR No. 06, Dated 14.01.2024, u/s 337-A(i)/447 PPC of Police Station Kalaya wherein, as per contents of FIR, the injured/complainant Ahmad Raza on 03.01.2024 at about 1610 hours vide Daily Diary No. 6 made a report to the local police to the fact that on the afore-mentioned date he was busy in cutting almond trees in his garden when the accused/petitioner armed with a stick in his hand came there and physically assaulted him. The complainant further claimed that the accused/petitioner struck him on the back of his head with a stone, resulting in severe injury. Hence, the instant FIR was registered.</p> <p>Arguments heard and record gone through perused.</p> <p>Perusal of the case file reveals that the accused/petitioner is directly nominated in the FIR. Counsel for the accused/petitioner failed to point out any malafidi or ulterior motive on behalf of police or the complainant for falsely implicating the accused/petitioner</p>


