A-4392 with a fixed charger and a spare charger containing 10 live rounds of 30-bore. Similarly, the personal search of a person namely, Aqid Ali occupying the front seat led the complainant to the recovery of a 12-bore rifle without number with a fixed charger containing 01 live round.

The petitioner present before the court produced original registration documents of the motorcar which were seen and returned.

- (3). Arguments heard and record gone through.
- (4). Perusal of the case file reveals that the petitioner is the last possessor of the motorcar in question. At present there is no rival claimant. Moreover, the investigation in the instant case is complete and the motorcar in question is no more required for further investigation.
- (5). In these circumstances, the petition in hand is accepted and the motorcar in question be returned to the petitioner subject to furnishing two surety bonds in the sum of Rs. 1,000,000/- to the satisfaction of SHO concerned.
