suit for declaration-cum-permanent injunction against the defendants to the effect that correct date of birth of the plaintiff is 01.01.1965, whereas, defendants have wrongly intered the same as 01.01.1977 in their record instead of 01.01.1965. That the correct date of birth of the real son namely Khaista Rehman, of the plaintiff is 1980, which results into an unnatural gap of 03 years between the dates of birth of the plaintiff and her son, which is wrong and ineffective upon the rights of the plaintiffs and is liable to correction. That the defendants were asked time and again to

do the aforesaid corrections, but they refused to do so, hence the present suit;

- 2. Defendants were summoned, who appeared before the court through their representative and contested the suit by filing their written statement.
- 3. Divergent pleadings of the parties were reduced into the following issues;

Issues:

- 1. Whether the plaintiff has got cause of action?
- 2. Whether the correct date of birth of the plaintiff is "01.01.1965" while defendants have wrongly entered the date of birth of plaintiff as 01.01.1977 in their record?
- 3. Whether the plaintiff is entitled to the decree as prayed for?
- 4. Relief?

Parties were given an opportunity to produce evidence which they did accordingly.

Issue wise findings of this court are as under: -

Issue No. 02

4. The plaintiff alleged in her plaint that correct date of birth of the plaintiff is 01.01.1965, whereas, defendants have wrongly entered the same as 01.01.1977 in their record instead of 01.01.1965. That the correct date of birth of the real son namely Khaista Rehman, of the plaintiff is 1980,

witnesses, in whom the one Dost Rehman, husband of the plaintiff, appeared as PW-01 and stated that he was married in 1977 and the age of his wife at that time was 15/16 years. Further narrated the same story as in the plaint and produced the copy of his CNIC which is Ex.PW-1/1.
